One of the missions of RISAA is to represent the concerns of the recreational community on regulatory and legislative issues. That means that we have to deal with elected officials.

Fortunately, there are a number of legislators who have worked hard on our behalf and others who support RISAA principles. We need to be sure those officials remain in office.

It is also important that legislators understand who we are. If we don't advance our own causes, no one will do it for us.

By law, our Association is an incorporated and non-profit organization. It has an independent Political Action Committee which is responsible for raising and disbursing funds for the Association's political activities. It has an independent

Only donations specifically made to the RISAA PAC can be used. Under no circumstances can any membership dues money - or any other contribution made to the Association - be used for the PAC. It would be a violation of state election laws for any money from RISAA to be used for PAC purposes.

Also, all money received by the PAC must come from *individual donors*. **No contribution can be accepted from any organization or business interest.**

How it works. The RISAA PAC Committee first receives requests for contributions. The committee determines a budget for the year, and then the money is forwarded to the final vote on all PAC issues. This is a 2-step process.
